## **The Science Granting Councils Initiative**

The Science Granting Council Initiative (SGCI) is an initiative which is jointly funded by the United Kingdom's Department for International Development (DFID), Canada's International Development Research Centre (IDRC), and South Africa's National Research Foundation (NRF) and aims to strengthen the capacities of 15 science granting councils in Sub-Saharan Africa in order to support research and evidence-based policies that will contribute to economic and social development.

SARIMA is a stakeholder organisation that operates at an institutional, national and international level, as well as across the value chain, from research through to successful innovation (commercialization). SARIMA provides a platform for promoting and facilitating of best practice in research and innovation management and aims to strengthen the research and innovation system to ensure the social and economic development of the Southern African region and the African continent at large

SARIMA, together with its partners and in collaboration with the other CTAs, finalised Theme 1 of the SGCI and the objectives are:

#### The objectives are:

- To understand the current capacity and capacity development needs of the participating SGCs
- To strengthen sustainable research management capacity of SGCs through professional development and training
- To strengthen sustainable research management capacity of participating SGCs through collaborative platforms
- To support benchmarking of participating SGCs through an online benchmarking tool

This newsletter serves to share some of the highlights on our activities with stakeholders from January 2019-March 2020.

# Strengthening sustainable research management capacity through professional development and training

#### **Professionalisation in Research Management**

The International Professional Recognition Council (IPRC) is a body that awards professional recognition for experienced research managers in Africa and provides continuous education points for training and other relevant events related to professional recognition. SARIMA initiated a consultative project to design a Professional Competency Framework (PCF) for research managers and administrators in southern Africa. The overarching role of the IPRC is to benchmark research management using the PCF by ensuring the quality and standards for individual professional recognition of research managers is the same in all countries in Africa.



International Professional Recognition Committee (IPRC) conducted a pre-pilot phase for two to three IPRC members which was initiated in March 2018. This allowed feedback to refine the Professional Recognition(PR) process before moving into the pilot phase. After reflecting on lessons learnt, SARIMA conducted a pilot professional recognition process specifically for the SGCI call on 29 September 2018- 20 November 2019. Two applications met the requirements to be reviewed by the IPRC with one applicant receiving a provisional Research Management Professional (RMP) status. The IPRC will

grant the status upon receipt of the recommended submissions and / or amendments for second submission.

On 15 August 2019, IPRC launched an open call for applications on professional recognition in research management. SARIMA accommodated the SGCI applicants by offering a closed call offering additional support in the application process and translation of call documents. Additionally, promotional and educational webinars were hosted on the on 10 September 2019 with two separate English and French sessions to build an understanding of the PCF and PR process.

The first applicant from the SGC's in the open call is currently in the review process, if the applicant becomes certified, she will be among the first certified Research Management Professionals on the continent, a substantial accomplishment as the applicant who will be a pioneer in professionalising Research Managers in Africa. The review outcomes will be released by 31 March 2020.

#### **Online Short Courses**

#### 13 countries participated

SARIMA has chosen to partner with The University of Witwatersrand (Wits) and Digital Campus to bring this set of online short courses to the Research Management (RM) profession to provide a flexible learning solution that ensures improvement in the general level of skill in RM practitioners and cements the professional standards required.

The six courses have been developed as fully online learning experiences. Each course can be taken in isolation or as part of a Competence Development Programme in Research Management.

SARIMA concluded the cohort of learners from the various SGCs. The learners who passed the courses received their certificates showcasing their competence in the respective areas of focus. Supplementary exams were rolled out in order to ensure that those who narrowly missed the pass mark receive another chance to successfully complete the courses. The above graph highlights the willingness of the SGC's to improve the level of knowledge of their employees in regards with Research Management.




#### **Development of a generic SGC manual template**

The initiating question for the development of the manual was: If a science granting council had a generic Grants Management manual that included all the councils' policies and procedures what would it look like? SARIMA interacted with the countries participating in the SGCI to obtain their views from conceptualisation and development of the document. The inputs have been crafted into a draft document that was circulated to various Research Management and Innovation stakeholders.

During the close-out workshop held on 13 February 2020 in Dakar, Senegal facilitated by
Dr Yolanda Davids, SARIMA used the opportunity to gather final review inputs from the SGCs to finalise the draft manual. Participating SGCs included: Botswana, Cote d'Ivoire, Kenya, Malawi, Mozambique, Namibia, Rwanda, Tanzania, Uganda, Zambia, and Zimbabwe.
SARIMA is in the final stages of revising the manual according to the inputs received by the SGCs. The final Generic manual will be uploaded onto the SGCI Virtual Hub where the SGC's will have access to it.

The Generic Operations manual will act as a template that the SGC's can use and adapt to their needs, providing the SGC's with foundation that they can build upon.

# Strengthening sustainable research management capacity through collaborative platforms

IT specific Learning Visit to the Uganda National Council for Science and Technology



SARIMA and the Uganda National Council for Science and Technology (UNCST) co-hosted the IT specific Learning in October 2019 visit. Eight countries were represented within SGCs staff members from Namibia, Ghana, Burkina Faso, Zambia, Malawi, Côte d'Ivoire, Senegal, and Mozambique. The IT specific learning visit created a platform for SGCs to engage, learn from each other and to share best practices and expertise in Research Management specifically Online Grants Management systems.

The learning visit programme was developed in close consultation with the SGCs to ensure the visit meets the participants' expectations. During the visit presentations, each country presented their current situation and analysed their needs with Online Grants Management System in order to provide an understanding of similar and differing needs. UNCST with a more advanced system shared their best practices by showcasing their online grants management system and explored the possibility of

extending their system to be used as generic online grants management system for other SGCs.

These discussions allowed for gaps to be identified between the various SGCs. The participants then reflected on their respective processes and they can incorporate new/learned information into their different environments. The visit strengthened the stage for increased cohesion between the SGCs where the various SGCs can learn from each other.



The different councils came together and shared experiences and we are so grateful for SARIMA for providing support and technical input.

## SARIMA Participation at the Monitoring, Evaluation and Learning Systems Workshop: June 2019 Annual Regional Forum- Addis Ababa

A two-day training workshop was organized by the Association of African Universities (AAU) under Theme 3 was designed to focus on the development of organisation wide M&E systems and how they can enable more effective management of research activities, specifically collaborative research efforts.

This workshop had synergies with Themes
1 (research management) and Theme 2
(STI indicators) and has been organised in
consultation with SARIMA and New Partnership
for Africa's Development (NEPAD) implementing
themes 1 and 2, respectively.

SARIMA shared the needs assessment data from countries that requested M&E support. The data assisted the AAU to identify target countries for their intervention and workshop. During the workshop SARIMA shared the experiences in implementing Theme 1 interventions with a focus in M&E and coordinated FNI to share their story to highlight the impact of SARIMA's intervention.

The interactions from the workshop created future coordinating activities of the AAU M&E Framework and SARIMA visit for countries requesting support in M&E.

# The Benchmarking Exercise (led by the Association of Commonwealth Universities)

SGCs submitted their data for the 2019 (the third) annual benchmarking exercise. The participating SGCs and the funders can log-into the online benchmarking platform to run their own, detailed benchmarking reports, based on the survey data.

In 2019, the benchmarking exercise was supplemented by two activities

- The SGCs participated in a discussion session (held at the MEL workshop, in Addis Ababa, in June), specifically for the benchmarking exercise. The session was very informative

   it highlighted useful information, notably in the area of collating gender and other diversity data. Key points captured from the session are being used to inform the recommendations outlined in the final (open access) benchmarking report.
- Phone and online meetings around the Technical Assistance Visits (TAVs) were held they helped situate the benchmarking exercise in the context of the wider Theme 1 objectives.

Communication following the TAVs identified changes in behaviour with 2 SGCs, as a direct result of participating in the benchmarking exercises. One SGC reported

the benchmarking exercise has helped us a lot in streamlining some of our existing processes and has also helped us to include some activities in our plan

(NCST, Rwanda).



Overall, the benchmarking data captured between 2017 and 2019 evidences changes and/ or improvements in SGCs' competencies (i.e., more SGCs rate their competencies as satisfactory and/ or above in more areas) since the implementation of the SGCI.

#### The Virtual Hub

Over the course of SGCI Phase 1, SARIMA dissemination a substantial number of news articles, resources, and CTA upload/publishing. There are currently 95 active user accounts for the SGCI Virtual Hub.
